

OFFICIAL RULES & REGULATIONS

PALM BEACH TAN (in PARTNERSHIP WITH "SNATCHED" THE MOVIE) SNATCHED SWEEPSTAKES

- 1. Eligibility:** The Palm Beach Tan (in Partnership with "Snatched" The Movie) Snatched Sweepstakes ("Sweepstakes") is only open to entrants who, at the time of entry, are: (a) natural persons who are legal residents of one of the 50 United States or the District of Columbia, and (b) 18 years of age or older. General Conditions on Entry:** Once submitted, all entries become the exclusive property of Sponsor and will not be acknowledged or returned, nor will any correspondence be exchanged with any entrant. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different e-mail addresses, identities, registrations, logins, or any other methods will void entrant's entries and that entrant will be disqualified. If any prize notification or prize is returned as non-deliverable, such prize will be forfeited and an alternate winner may be selected as further described in Section 8 above. Noncompliance with any of the foregoing or any portion of these Official Rules may result in disqualification and awarding of the prize to an alternate winner. Federal, state, provincial, territorial, and local taxes and all other expenses not specified herein are winner's sole responsibility. If a winner is a U.S. resident, he/she may receive an IRS Form 1099 reflecting the actual value of his/her prize.
