## **OFFICIAL RULES**

## PALM BEACH TAN SPRING CHA-CHING GIVEAWAY

- 1. Eligibility: The Palm Beach Tan Spring Cha-Ching Giveaway ("Giveaway") is only open to entrants who, at the time of entry, are: (a) natural persons who are legal residents of one of the 50 United States or the District of Columbia, and (b) 18 years of age or older. - 4. **Timing**: Giveaway begins at 12:00:01 A.M. Central Time ("CT") on April 6, 2018 and ends at 11:59:59 P.M. CT on April 15, 2018 ("Giveaway Period"). Sponsor's computer is the Giveaway's official clock.
- 5. **How to Enter**: You must register for the Giveaway through palmbeachtan.com/info/sweepstakes. Standard internet access and usage charges imposed by your online service provider will apply.
  - **Additional Giveaway Entries:** After entering the Giveaway as described above, you may submit additional entries into the Giveaway drawing once per calendar day throughout the Giveaway Period.
- 6. **General Conditions on Entry**: Once submitted, all entries become the exclusive property of Sponsor and will not be acknowledged or returned, nor will any correspondence be exchanged with any entrant.
